CONCERN ABOUT THE DELAY IN THE INVESTIGATION OF R61m KZN MOBILE CLINIC TENDER

In my letter addressed to your predecessor, Advocated Thuli Madonsela dated 19th June 2015 I raised my concerns regarding this controversial tender and requested your office to investigate but no progress has been reported in this matter since then. This R61million tender saw the KwaZulu-Natal Department of Health lease mobile clinic units from two companies viz Mzansi Lifecare and Mobile Satellite Technologies. Upon receiving a letter of confirmation from Advocate Thuli Madonsela I had high hopes that before her term of office came to an end I will be given an update on progress in this matter.

There was a confirmation by your spokesperson in May 2016 that the Public Protector has taken a decision to investigate the tender but to date I have not received any communication from your office.

I would appreciate feedback on what progress has been made in this matter and if there is a timeframe by which a final report will be available.

It would be painful to me if this matter is not followed to a logical conclusion because we have asked the KZN Health MEC, Dr Sibongiseni Dhlomo about this tender but he has ignored our questions. The Inkatha Freedom Party wants to get answers because it is of the view that corruption is involved and public funds have been squandered.
